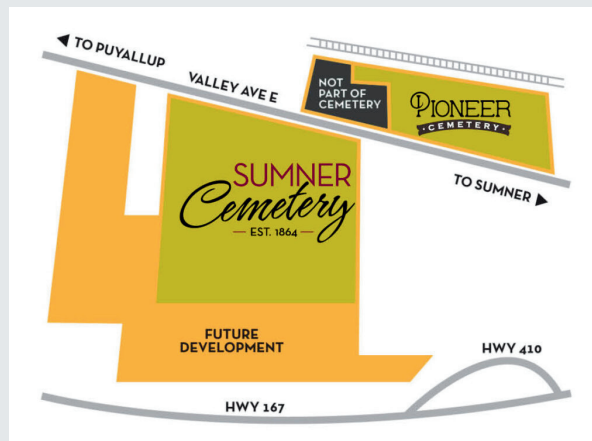

**From Sumner's Main Street**, go across the Cannery Way Bridge and follow the road as it curves west. Sumner Cemetery will be on your right (Pioneer Cemetery) and left (Main area) in approximately 1 mile.

**From SR 167**, take the first SR 410 exit and turn left onto Sumner's Traffic Avenue. Proceed north to Main Street and at the light with Main, turn left onto the Cannery Way Bridge.

Located in Pierce County, Washington, the Sumner Cemetery serves the South Puget Sound region. We are located on Valley Ave between the City of Puyallup and the City of Sumner.

Established in 1864 the Pioneer Cemetery was created to accommodate the settlers of the valley. The cemetery expanded as needed eventually including acreage across Valley Ave. The City of Sumner began managing the Cemetery in the 1920's.



We provide a range of services, a place for reflection, and a source of genealogical data, all in a historic and park like setting.

*The Sumner Cemetery has many options. We offer plots with flat marker or upright monuments, to provide a more traditional burial site. We have several options for cremation interment, including traditional urn gardens, glass front niches, and granite niche wall as well as our Heritage Farm. Our newest addition is the Rainier Valley Green Burial section. This option allows those that do not wish to use modern methods for burial that include no embalming, cement vaults or metals caskets.*

## Chapel MAUSOLEUM

The Glass Front Niche offers an option for urn placement in an indoor setting.

## HERITAGE FARM

Celebrating the heritage of the valley and its farming roots, this urn garden allows and companion plots single available. The wishing well allows for scattering of cremains.



## Granite Niche Wall

Allows for placement of 2 urns and has a granite front ready for engraving.
