SUMMARY BACKGROUND:

At the August 17th regular council meeting, council appointed Mark Isaacs to the vacant council seat.

Resolution No. 1695 adopted the council's rules of procedure for the conduct of Council Meetings, proceedings, and business. Section 24.9 states that a newly appointed councilmember shall "be sworn into office and seated at the next regular council meeting."

The next regular council meeting isn't until September 8th, meaning that Mr. Isaacs would be unable to participate in the upcoming community partner fund allocations or budget retreat.

Staff recommends that council exercise Section 22 of their rules to suspend the rules, allowing Mr. Isaacs to be sworn in at tonight's special council meeting.
