Agenda item: Bennett Property – Park name and theme

Discussion: The Commission discussed the results from Daffodil Valley Elementary and the Sumner Library voting. Community Services Manager Barry shared his concern of the park being named “Creekside” as this could lead people and some of the residents of Creekside to believe or act as though the park was private or run by the Creekside HOA. The Commission was asked to cast their votes or their top three names over the next month. Taking all of the voting into account the Commission will be making a recommendation to the Mayor and Council, likely of two or three names that best represent the vision of the park as well as top ranked by each group or in whole.

Agenda item: Graffiti & Vandalism

Discussion: The level of graffiti has dropped considerably. The idea of the graffiti wall could have unintended consequences. Staff shared concerns of who and how do you handle protected speech while also keeping a community feel. Community Services Manager Barry suggested this concept be kept as a possible approach if/when it needs to be discussed again.

Agenda item: Cemetery Trees

Discussion: A large section of the biggest tree at the Cemetery came down during the April 4th wind event. Cemetery staff worked alongside Parks and PW staff to clear the tree and assess the damage. The pine tree will likely need to be removed in the coming months due to the wounds potential for rotting.
